 - a) Report

Marg Krauter shared that most of the activities of the executive will come up in reports.

b) Nominations

MOTION by Rev. Dennis Posno / Mary McKeen that Northern Waters Presbytery appoint Rev. Kent Ward as a director (2 yr) of PTCC (extending his term until the annual meeting of PTCC in 2021) and Betty Morrison, Marg Krauter and Mary Ellen Parsons as members (3 yr) of PTCC (until annual meeting of PTCC in 2022).

2. Congregational Life Commission –

Report Rev. Bruce Gregersen talked about the United Church of Christ in the United States (congregational style organization) and how it differs to The United Church of Canada (conciliatory organization) and what we can learn from each other. The Congregational Life Commission nurtures the well-being of the communities of faith. They ensure supervision of pastoral charges if there is no minister; Congregational Life struggles to get supervisors. In The United Church of Canada property is owned by the whole. In the new model how will this oversight of communities of faith be done? They are also involved with churches that are closing, dealing with the property and honouring the churches. Waverley, Walters Falls, Marsville, Chatsworth, and Salem United Churches are now closed. Two are in transition to other uses. Tottenham-Rich Hill Pastoral Charge is using manse funds to help with mental health initiatives. Inglewood will have a facilitator for two years as they define their role. Closing is a last resort. There is concern on how projects will continue such as St. Paul's Midland as a hub through technology and the ways in which they interact. It will be in place shortly.

3. Governance Commission – Rev. Kent Ward

a) Report

Mission Support grants will be taken over by the regional commissions; Grey Bruce Regional Health Services Chaplaincy request has been forwarded to Region 8.

b) Financial Report

Mary McKeen reviewed the financials with figures as of August 31st. She reminded everyone to submit mileage forms once the amount reaches \$25.00. \$10,000 went to Indigenous ministries in Toronto Conference to top up Mission Support. **Error! Reference source not found.**

MOTION by Rev. Kent Ward / Judy Chalmers that Northern Waters Presbytery agrees that, for the purpose of the Operating Agreement dated October 1st, 2010 as amended April 20th, 2016, between PTCC, Toronto Conference and the four presbyteries, Region 10 is successor to Toronto Conference, Living Waters Presbytery, Toronto Southeast Presbytery and South West Presbytery and Region 8 is successor to Northern Waters Presbytery.

ii. PTCC Funds Endorsement

MOTION by Rev. Kent Ward / Judy Chalmers that Northern Waters Presbytery endorse the concept that, in due course, the PTCC funds of Living Waters Presbytery, Toronto Southeast Presbytery and South West Presbytery will merge into one fund for Region 10 and the fund of Northern Waters Presbytery will become the fund of Region 8.

e) New Ministries Development and Leadership Fund
 This fund is available to programs and ministries through all four presbyteries.
 We would like to encourage all the presbyteries that this fund remain intact and seek that both Region 10 and Region 8 be part of the fund together.

MOTION by Rev. Kent Ward / Judy Chalmers that Northern Waters Presbytery agree to the following:

- that the New Ministries Development and Leadership Fund continue for two years beginning January 1, 2019 and operate according to the current terms of reference;
- as per the Memorandum of Understanding dated November 23rd, 2016, between PTCC, Toronto Conference and the four presbyteries, that Region 10 be the successor for Toronto Conference, Living Waters Presbytery, Toronto Southeast Presbytery and South West Presbytery and that Region 8 be the successor for Northern Waters Presbytery;
- the grant selection committee will be housed in Region 10 with grant applications accepted from both Region 10 (for ³/₄ of the fund as at December 31st, 2018) and Region 8 (for ¹/₄ of the fund as at December 31st 2018);
- that there be two people from Region 8 on the grant selection committee during this interim period;
- that Region 10 be asked to include the grant selection committee in its governance structure;
- as of January 1, 2019 and during the interim period, Region 10 may choose to contribute to the fund for Region 10 and Region 8 may choose to contribute to the fund for Region 8; and
- during this interim period, Region 10 and Region 8 will discuss how they would like the fund to continue beyond 2020.

4. Education & Students

Rev. Todd McDonald provide an update. Some work will go to National Church.
 Preparation and formation of ministers ordered and lay will go to the national Office of Vocation. After ordination, designation and commission and the recommendation will go to the Region who holds the celebration of ministry. Right now NW has no candidates

but we have inquirers and this information will go to the Office of Vocation and they will follow with those people the next steps.

5. Program Commission

a) Report Rev. Kerrie Perry

There are still some funds available since two events were cancelled. Funds helped Camp Simpresca purchase a new stove. There are ten youth heading to BC Conference for *Evolve*. Thirty-four are going to the *Niagara Youth Festival*. Newsletter information still can be sent in but the deadline is usually the 28th. Presbyterial met last week and met with some from Region 8. The National UCW is beginning a four-year funding project for education of girls in Zambia. Three of the four camps in Northern Waters will be part of Region 10. The Commission is doing the planning for attending *Worshiplude* in Ottawa in February.

Announcements & Lunch at 12:00 noon

Gathering

Presbytery Chair, Marg Krauter, called the gathering to order at 1:00 p.m.

General Council Report – GC Commissioners

Cassie Vermeer-Korittko provided an overview of General Council 43. The Festival of Faith preceded the business. She took part in a disabilities workshop. She said that it was difficult to choose the moderator. She shared the experience on the Friday where the church was challenged to recognize its own racism and the marginalization of racialized members. They listened to those who felt marginalized because of race.

Rev. Neil Parker described the business processes. To include more people closed captioning and American Sign Language were provided. They used the clicker for voting. Results were shown immediately and they could see whether all had voted. Even when a motion passed it was possible to see whether some opposed the motion. There were table groups, listening sessions, facilitation groups and decision sessions. Information was recorded during the discussions and the information then went to the facilitation group. When the commissioners came together the next day, they heard the facilitation group's summary. The facilitation group made suggestions of what should be done. It was a challenge for the facilitation group to synthesize all the information concerning the proposals. The large group had to make decisions. Instead of paper format information, before the commissioners arrived they had information electronically and got updates as they changed.

Rev. Kristal McGee attended on behalf of Toronto Conference. There were calls for reconciliation. The caretakers' reports were received from a group who have made it their work for over a decade. The indigenous will say what their ministry is like and they will do Indigenous theology. There are 644 different languages in North America among the indigenous people. They are not homogenized. Some have chosen to be part of presbytery or not; and in the new regional set up they can be part of a region and also the All Native Circle if they wish.

Rev. Nicholas Forrester –Commissioners were challenged at their core. Many left feeling hopeful about where the church is and what it is going to be. This was his first experience at

General Council. At the end of Friday afternoon the business was disrupted and the church was called to face an issue, racism, not only present in this country, continent and much present also in the United Church of Canada. They were challenged to face this issue. There is a greater push to be an intercultural church; it is a justice issue that we must confront. Other aspects that were hopeful were making Christ centre of everything we do and the engagement of Christ in our midst. Recognizing that Christ is the centre gives him hope.

Marg Krauter thanked the commissioners for their commitment for eight days plus the preparation time.

Regional Commissions report

a) Region 10 – Rev. Kent Ward and Rev. Ross Leckie

They are the two reps on Region 10 from Northern Waters Presbytery. They have had three meetings since the end of June with two co-chairs. The executive minister, Rev. Peter Hartmans, also covers region 6 to the north and the region is also sharing some staff with region 6.

They are looking at what they are going to do with the current offices and what will be used in the future. The indigenous churches will decide what they want to have the church look like. The region is looking at a gathering at the end of May. No name has been decided upon. Toronto Conference website has information under Transition. The region will eventually have its own website.

b) Region 8 – Marg Krauter

Connecting, supporting and transforming are the key words for the mission of Region 8. In her presentation, she named the new staff that has been hired. Some staff will be shared among regions 7, 8 and 9. The current Hamilton Conference office will be used and the three regions will share space. The London and Alliston offices are in rented spaces. As a rule the staff will go to the people and instead of people going to the office. The commissioners are mostly from small places. They also have had two joint meetings with 7 and 9 in London. Communication is important and there are updates by email. There is a gathering for region 8 in Mount Forest on October 20. It is a chance to meet and there will possibly be a speaker in the afternoon. It is free but a person needs to register in advance. The annual meeting is scheduled at the Unifor Centre in Port Elgin the last weekend in May. It will be a decision making meeting and the election of the first official executive. The commissioners haven't decided yet about committees, etc. On October 10 staff and commissioners will meet to discuss governance issues.
